# Membership Terms & Conditions

- Financial membership year for Gainsborough Greens Golf Course is a 12-month contract from the date you join. Renewals are effective immediately upon expiry of your membership. If membership is rolled over without signing new membership form, the Membership Terms & Condition on this form will still be active.
- Members are required to register at the golf shop at least 15 minutes prior to scheduled tee time and produce their current membership card. Failure to produce current membership card may result in the refusal of play. Members must not allow their membership card to be used by any other person. In the event of cancellation, player is to advise staff, preferably the previous day. Members are requested to book all games through the golf shop or via the members portal on the website.
- Gainsborough Green Golf Course may reject any application for membership, without assigning a reason.
- Gainsborough Green Golf Course may establish rules for management of its facilities. This includes but is not limited to from time-to-time adjustment of booking times, hours of operation and the closure of the facilities for tournaments, weather conditions, maintenance, or other reasons.
- Gainsborough Greens Golf Course guarantees a “365-day membership”. In the event Gainsborough Green Golf Course is closed due to flooding for every day the course is closed a day will be added to your membership.
- Cart membership entitles the financial member to a seat in a cart within their membership category playing time. If there are 2 cart members or players paying for the hire of a cart in the same playing group, the cart must be shared. This will be managed by the golf shop staff.
- No refunds are payable for the termination of membership from any cause.
- Gainsborough Greens Golf Course may cancel the membership of any person or refuse permission for that person to use its facilities if that members breaches any rule or is guilty of misconduct within the facility.
- Handicaps will be maintained by Gainsborough Greens Golf Course for all members who nominate it as their “Home Club”. Gainsborough Green Golf Course shall not be liable, in any way, to members in respect of any errors or omissions made in the keeping of handicaps.
- Members exercise their rights and come upon and use the facilities of Gainsborough Greens Golf Course at their own risk. We will not be liable for damage to or loss of property of any member.
- These Terms and Conditions of Membership are designed to aid the efficient operation of the facilities of Gainsborough Greens Golf Course for the benefit of all. They may be changed by the management of the Golf Course at any time.
